The Legal 500 United States 2022 Edition Recommends Four Neal Gerber Eisenberg Practices and 19 Attorneys

Four Neal Gerber Eisenberg practice groups and 19 attorneys have been recognized among the top in the nation in the newly released 2022 edition of *The Legal 500 United States*.

The firm continues to be recommended in the areas of M&A/Corporate & Commercial: M&A: Middle-market (sub-\$500 million); Intellectual Property: Trademarks Litigation; Employee Benefits, Executive Compensation and Retirement Plans: Design; and US Taxes: Non-contentious. The M&A/Corporate & Commercial recognition is in Tier 2.

The Legal 500 notes the Corporate & Securities practice group, chaired by John Koenigsknecht, is regarded for its "very high level of service and availability."
