### U.S. News – Best Lawyers 2017 “Best Law Firms” Recognizes 23 Neal Gerber Eisenberg Practices

Twenty-three Neal, Gerber & Eisenberg LLP practice groups have received recognition in the 2017 edition of *U.S. News – Best Lawyers*® “Best Law Firms.” At the national level, 19 practices were ranked, with 23 practices earning a ranking among the top in Chicago. Joining the rankings for the first time is “Patent Law” at Tier 2 for Chicago.
