U.S. News – Best Lawyers 2022 Best Law Firms Recognizes 24 Neal Gerber Eisenberg Practices

Twenty-four Neal Gerber Eisenberg practice groups have received recognition in the 2021 edition of *U.S. News – Best Lawyers* “Best Law Firms.” At the national level, 22 practices were ranked, with 24 practices earning a ranking among the top in Chicago.
