In addition to serving on the CWC's Advisory Board, Jonathan has represented several of the Center's clients, including having secured an acquittal in November 2017 at the second murder trial of a woman previously convicted and who had served eight years in prison.

When not serving clients, Jonathan can be found educating the lawyers of tomorrow. He is an adjunct professor of trial advocacy at Northwestern Pritzker School of Law and is also a faculty member of the National Institute for Trial Advocacy.
